### Vendor Instructions for Lock 60 Area

#### Detailed Instructions

1. Drop-off for set up must be completed no later than 8:30 AM. Towpath Road will be closed to vehicular traffic by 8:45 AM and remain closed until 4 PM.
2. All vendors must stay for the entire day or be able to walk to parked car at St. Michael's Park. All materials and items brought to the event must be removed by vendor upon leaving.
3. Follow the directions below; go to the main tent at Lock 60 to sign-in and get your space location and parking instructions.
4. **PLEASE** bring this form with you on Canal Day; it is your **entry pass**.
5. **Limited electric** is available; please provide your own small, quiet gasoline or propane generators if available.
6. Exhibit area is located at the end of Towpath Road where all the activities will be held; food, live music, water sport competitions, kid's games & crafts and many other events.
7. We will make every effort to ensure that your experience will be enjoyable.

#### Directions:

From Rt. 422 E or W – Collegeville exit to Rt. 29 South (Collegeville Road). Follow Rt. 29S for 3 miles. Go through flashing yellow light at Egypt Rd. through next traffic light (Jacobs & Bridge Sts.). Turn right onto Towpath Road, which is a single-lane road between the canal and river (signs marked Lock 60), across from Produce Junction.

From Rt. 29 N – turn left onto Towpath Road, the single-lane road between the canal and river across from Produce Junction.

Follow the one-lane road until you reach the end, where the Business Expo will be set up. Cars are permitted to stay with vendor only if space permits. Otherwise, all vendors will be asked to park cars at St. Michael's Park, at the end of Jacobs Street, Mont Clare, PA.
