### Detailed Instructions

1. Drop-off day & time: Friday, 6/25, 4:00 to 7:00 PM. If an alternative time is needed contact SCA at the number, email listed above.
2. Artwork will be set-up by the PVAC on the Locktender's House porch and on the first floor inside the house.
3. Artists should provide their own easel, if available.
4. Unsold artwork must be picked up after the close of Canal Day, Sunday, 6/27/10, at 4 PM but no later than 5:00 PM that afternoon. All remaining artwork will be taken back to the PVAC for pickup at the Phoenix Village Art Center Art Center at their convenience.

**Directions:** Visit SCA's website, [www.schuylkillcanal.org](http://www.schuylkillcanal.org), to view a map indicating approximate location. From there follow the directions below:

**From Rt. 422 E or W** – Collegeville exit to Rt. 29 South (Collegeville Road). Follow Rt. 29 S for 3 miles. Go through flashing yellow light at Egypt Rd. and at the next traffic light (Jacobs & Bridge Sts.), continue straight through (200 yards) to Lock 60 entrance. on right. Follow Towpath Road to Lock 60, cross over the truss bridge, drop off artwork at the Locktender's House.

**From Phoenixville** traveling on Rt. 29 N – turn left (200 yards from Produce Junction) before finishing crossing the Schuylkill River from Phoenixville. Lock 60 entrance is on the left. Follow Towpath Road to Lock 60, cross over the truss bridge, drop off artwork at the Locktender's House.
